Australian Go Association Annual General Meeting 2016

Minutes of the meeting

Location

The meeting opened at 12:05pm, Saturday 3rd December at Box Hill Town Hall, Whitehorse Road, Melbourne.

Meeting Officials

The meeting was presided over by David Mitchell (chairman and minute taker); Horatio Davis (treasurer) and Neville Smythe.

Minutes of previous meeting

The minutes of the previous meeting were read and agreed a true record. Proposed by Horatio Davis, Seconded by Neville Smythe - passed unanimously.

Matters arising

The travel scholarship was discussed. Despite direct e-mail to all members and promotion on social media the initiative received little support. Because of the lack of interest the meeting decided to revert to the previous ad-hoc scholarship process.

David Mitchell reported that the AGA rating system had been overhauled by a small group with particular thanks extended to Neville Smythe who worked tirelessly on the software. The AGA have a flagship rank of 7dan which is only given where a player has achieved the required number of promotion points, won at least 2 National events and has the approval of the National Coach. A small group headed by Neville will maintain the system over the coming years.

Reports

There was no report from the President (Raphael Shin).

Horatio Davis provided a detailed treasurer's report is attached. Horatio also provided a commentary on the finances. Neville Smythe proposed the accounts be accepted, seconded by David Mitchell - the motion was passed unopposed.

The secretary's report was delivered by David Mitchell (attached). A motion to accept the report was proposed by James Kaaden, seconded by Neville Smythe - passed unanimously.

Election of office bearers for 2016

President: David Mitchell proposed Raphael Shin continue as president – Raphael had previously accepted the nomination. The proposal was seconded by Horatio Davis and with no other candidates Raphael was elected unopposed.

Vice President: David Mitchell proposed Neville Smythe as vice president – Neville accepted the nomination. The proposal was seconded and with no other candidates Neville was elected unopposed.

Treasurer: Neville Smythe proposed Horatio Davis for the role as treasurer. Horatio accepted the nomination which was seconded by Billy Sun - with no other candidates Horatio was elected unopposed.

Secretary: Horatio Davis proposed David Mitchell as secretary. David accepted the proposal which was seconded by Neville Smythe and with no other candidates David was elected unopposed.

Other committee members:

The meeting elected unopposed the following people as ordinary members of the committee:

Matthew Crossman, An Younggil, Yoko Usami, Erli Qiu, Billy Sun and James Kaaden – there being no other candidates these people were elected to the committee.

Incorporation of the AGA

David Mitchell proposed that the meeting direct the committee to investigate and incorporate the AGA. Currently the AGA is not an incorporated entity which means it has no legal status – effectively the membership entrusts all AGA assets to the officers to do with as they wish. Without incorporation the AGA cannot apply for grants, cannot be left bequests – it also means the officers of the Association are personally liable for any legal action. Neville Smythe seconded the proposal.

Horatio Davis opposed the proposal – he felt incorporation was costly in terms of man power and there was no immediate need.

There were 8 in favour, 2 against and 36 who abstained. Given the lack of support for the proposal the proposal was withdrawn.

Constitutional change

A proposal to change the constitution in preparation for incorporation was withdrawn.

Location of 2017 National Championships

Sydney is the next location in the cycle – Horatio Davis proposed Sydney organize the 2016 National Championships, Seconded by Neville Smythe. David Mitchell accepted the proposal on behalf of the Australian Go Congress Organizing Committee and the Sydney clubs. The motion was passed unanimously.

AGA Secretary's Report for 2016

2016 has been a busy year for the AGA committee, there have been 4 committee meetings so far and another is scheduled for December 2nd just before the National Championships in Melbourne.

The strong support for the AGA and Go players in Australia from the Korean Amateur Baduk Association (KABA) continued throughout the year. Yiannes Pache-Newman spent two months studying Go with up and coming Korean players and top professionals with all expenses paid by KABA. KABA have also sent beginner's sets and teaching equipment to support new AGA clubs and the AGA Youth initiative.

The second Australian Go Congress was held in Parramatta in over 3 days in January but local players failed to participate. The support from Raphael Shin and the Hanho Newspaper is significant and the Congress is a rare opportunity to build the base of Go players and publicize the game. The 2017 Congress will be held at The University of Sydney later in the year (Sept/Oct) with invitations being sent to Korea, China, Japan, Malaysia, Vietnam, Taiwan, USA and Europe. AGA members who want to spread and support the game should attend this and all other Go events.

During 2016 there have been new projects as well as the continuation of existing initiatives. In summary, the AGA achievements are:

- The revision of the AGA rating system and the upgrade of the Agatha system to suit the new ratings process.
- The establishment of the rules and implementation of the 2016 Travel Scholarship. This was a significant point of discussion at the 2015 AGM but support (in terms of applications for the scholarship) has been well below expectation. Just one application was received despite e-mails to all members and publicity on Facebook and other social media.
- The staging of the second Online Go Tournament – this attracted more players, including those from Far Eastern Australia (a.k.a. New Zealand) who took the honors.
- The Youth sub-committee continues its work to promote Go to young people around Australia. There was an 'incursion' at Forest Lodge Primary School and a new club has been formed at Churchlands in Perth has been sent books and sets.
- A review of the AGA constitution and the AGAs legal status leading to two proposals at the 2017 AGM. I've included an extract on what this means at the end of this report.
- The continued use of social media extending on the Facebook presence with a Twitter account (thanks to Horatio) has helped spread day to day news more freely amongst members.

AGA Legal status

The AGA is an unincorporated entity; the following extract explains the situation.

"Unincorporated associations are not regarded as legal entities by law even though their members may regard them as independent organisations. They are really only a collection of people acting together. This is the most obvious difference between unincorporated and incorporated organisations.

Members of an unincorporated association are, subject to the powers of the association's constitution, capable of entering into contracts and doing things on behalf of other people in the association. They are also individually and personally responsible for any debts incurred in the name of the association. Where a contract is signed on behalf of an unincorporated association, the individual members are responsible and may be sued. Similarly, if someone is injured through an unincorporated association's negligence and there is no insurance, the association cannot be sued but individual members may be sued."
